Effectively managing today’s complex IT organizations requires a new level of integrated visibility and control across the activities and functions of IT.



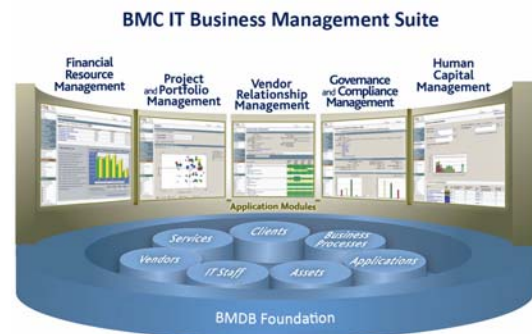
